We wish to advise you and give notice that Aberystwyth Town Football Club intend to apply for full planning permission for the redevelopment of the venue, which includes the erection of a new clubhouse, turnstile, changing rooms and seated stand, with new roofing over the existing terraced areas and associated works. The redevelopment of the venue also includes an outline planning permission for the construction of new residential accommodation provided as apartments, similar to the adjacent residential development. A full description of the works is provided in the planning statement and supporting documentation.
